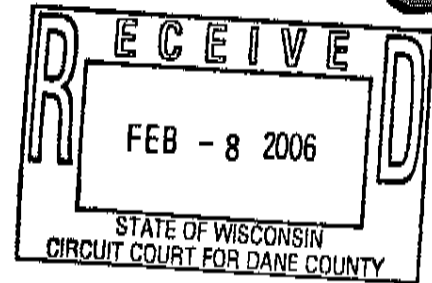



Enclosed please find the State's Revised Witness List in the above referenced case. The state eliminates a large number of names and adds only one, Nicole Schroeder. The state also requests that the defense, having now received this revised list, now promptly produce a revised witness list consistent with the court's rulings of February 3, 2006, since the court's rulings precluded the ability of the defense to call a large percentage of those named on the defendants' initial witness list. The state should not be left to wonder which names were part of a defense theories of "everyone does it" or "the other side does it," or part of a court rejected approach by the defense that the jury defines the duty at issue.

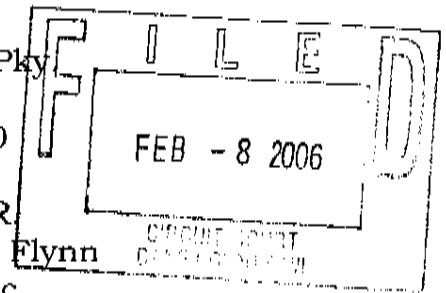
