2017 BILL

1 **AN ACT** *to amend* 71.05 (6) (a) 15., 71.08 (1) (intro.), 71.10 (4) (i), 71.21 (4) (a),
2 71.26 (2) (a) 4., 71.30 (3) (f), 71.34 (1k) (g) and 238.12 (1); and *to create* 20.835
3 (2) (cq), 71.07 (3ym), 71.28 (3ym), 77.54 (67) and 238.165 of the statutes;
4 **relating to:** authorizing certain tax benefits for a paper products
5 manufacturer with facilities in the city of Neenah and village of Fox Crossing
6 and making an appropriation.

Analysis by the Legislative Reference Bureau

This bill authorizes the Wisconsin Economic Development Corporation to certify a certain paper products manufacturer to claim tax credits. The business certified by WEDC under the bill may claim as income and franchise tax credits a percentage of the business's eligible payroll for full-time employees, as defined in the bill, employed at the business's facilities in the city of Neenah and village of Fox Crossing, if the employment positions exist when the bill becomes law.

The bill further authorizes WEDC to certify the paper products manufacturer for additional income and franchise tax credits, subject to certain limitations, if the business makes a significant capital expenditure at a facility specified above. The bill also creates a sales and use tax exemption for the sale of building materials, supplies, and equipment used to construct or develop facilities located at a facility specified above if the capital expenditures for constructing or developing the facilities may be claimed as income and franchise tax credits by the business certified under the bill.

BILL

If the amount of any income and franchise tax credit under the bill exceeds the business's tax liability, the business receives a refund equal to the excess amount.

WEDC may seek repayment of tax credits that the business claims for a year in which the business failed to maintain employment levels or a significant capital investment in property required by contract between the business and WEDC. Also, WEDC must revoke the certification to claim tax credits if the business does any of the following:

1. Supplies false or misleading information to obtain the tax credits.
2. Leaves the state to conduct substantially the same business outside the state.
3. Ceases operations in the state and does not renew operation of the business or a similar business in the state within 12 months.
4. Fails to retain at least 93 percent of its full-time employees at the facilities specified above who were identified as being full-time employees of the business in the base year, as determined by WEDC.
5. Fails to retain at least 93 percent of its full-time employees employed in this state but outside the facilities specified above who were identified as being full-time employees of the business in the base year, as determined by WEDC.

A certification under the bill may remain in effect for no more than 15 years.

Because this bill relates to an exemption from state or local taxes, it may be referred to the Joint Survey Committee on Tax Exemptions for a report to be printed as an appendix to the bill.

For further information see the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

6 1. "Claimant" means a person who is certified to claim tax benefits under s.
7 238.165 (2) and who files a claim under this subsection.

8 2. "Eligible payroll" means the amount of state payroll that is attributable to
9 wages paid by the claimant to full-time employees. "Eligible payroll" does not
10 include the amount of wages paid to any full-time employee that exceeds \$100,000.

11 3. "Full-time employee" has the meaning given in s. 238.165 (1m) (a).

12 4. "State payroll" means the amount of payroll apportioned to this state, as

22 (bm) *Filing supplemental claims.* In addition to claiming the credit under par.

23 (b), and subject to the limitations under this subsection and s. 238.165, a claimant
24 may claim as a credit against the tax imposed under s. 71.02 or 71.08 an amount up

1 to 15 percent of the claimant's significant capital expenditures in this state in the
2 taxable year, as determined under s. 238.165 (4).

3 (c) *Limitations.* 1. Partnerships, limited liability companies, and tax-option
4 corporations may not claim the credit under this subsection, but the eligibility for,
5 and the amount of, the credit are based on their payment of amounts described under
6 pars. (b) and (bm). A partnership, limited liability company, or tax-option
7 corporation shall compute the amount of credit that each of its partners, members,
8 or shareholders may claim and shall provide that information to each of them.
9 Partners, members of limited liability companies, and shareholders of tax-option
10 corporations may claim the credit in proportion to their ownership interests.

11 2. No credit may be allowed under this subsection unless the claimant includes
12 with the claimant's return a copy of the claimant's certification for tax benefits under
13 s. 238.165 (2).

14 (d) *Administration.* 1. Section 71.28 (4) (g) and (h), as it applies to the credit
15 under s. 71.28 (4), applies to the credit under this subsection.

17 otherwise due on the claimant's income under s. 71.02, the amount of the claim that
18 is not used to offset those taxes shall be certified by the department of revenue to the

13 may claim as a credit against the tax imposed under s. 71.23 an amount up to 15
14 percent of the claimant's significant capital expenditures in this state in the taxable
15 year, as determined under s. 238.165 (4).

16 (c) *Limitations.* 1. Partnerships, limited liability companies, and tax-option
17 corporations may not claim the credit under this subsection, but the eligibility for,
18 and the amount of, the credit are based on their payment of amounts described under
19 pars. (b) and (bm). A partnership, limited liability company, or tax-option
20 corporation shall compute the amount of credit that each of its partners, members,
21 or shareholders may claim and shall provide that information to each of them.
22 Partners, members of limited liability companies, and shareholders of tax-option
23 corporations may claim the credit in proportion to their ownership interests.

1 capital in this state for the benefit and welfare of people throughout the state. The
2 tax benefits are therefore in the public interest and will serve a public purpose, and
3 it is the public policy of this state to provide the tax benefits under this section.

4 **(1m) DEFINITION.** In this section:

5 (a) "Full-time employee" means an individual who is employed at a facility
6 specified under sub. (2) (a) in a job for which the annual pay is at least \$30,000 and
7 who is offered retirement, health, and other benefits that are equivalent to the
8 retirement, health, and other benefits offered to an individual who is required to
9 work at least 2,080 hours per year.

22 corporation determines that a business certified under sub. (2) makes a significant
23 capital expenditure at a facility specified under sub. (2) (a), the corporation may
24 certify the business to receive additional tax benefits in an amount to be determined
25 by the corporation, but not exceeding 15 percent of the business's capital

2 allocate the tax benefits a business is certified to receive under this subsection over
3 a period of years.

4 (6) OTHER DUTIES. (a) The corporation shall revoke a certification under sub.
5 (2) if the business does any of the following:

- 6 1. Supplies false or misleading information to obtain tax benefits.
- 7 2. Leaves the state to conduct substantially the same business outside the
8 state.
- 9 3. Ceases operations in the state and does not renew operation of the business
10 or a similar business in the state within 12 months.
- 11 4. Fails to retain at least 93 percent of its full-time employees who were
12 identified as being full-time employees of the business in the base year, as
13 determined by the corporation.
- 14 5. Fails to retain at least 93 percent of its employees employed in a full-time
15 capacity in this state but not at the facilities specified under sub. (2) (a) who were
16 identified as being employees of the business so employed in the base year, as
17 determined by the corporation.

18 (b) The corporation may require a business to repay any tax benefits the
19 business claims for a year in which the business failed to maintain employment
20 levels or a significant capital investment in property required by contract between
21 the business and the corporation.

22 (c) The corporation shall determine the maximum amount of the tax benefits
23 that a certified business may claim and shall notify the department of revenue of this
24 amount. Tax benefits may be claimed for a full-time employee only if the employee

3 (d) The corporation shall annually verify the information submitted to the
4 corporation for purposes of ss. 71.07 (3ym) and 71.28 (3ym).

5 (e) The corporation shall adopt policies and procedures defining "significant
6 capital expenditure" for purposes of sub. (4).

7 **SECTION 14. Initial applicability.**

8 (1) SALES AND USE TAX EXEMPTION. The treatment of section 77.54 (67) of the
9 statutes first applies to purchases made by a business after the Wisconsin Economic
10 Development Corporation enters into a contract with the business under section
11 238.165 (2) (b) of the statutes.
