DE PERE –1<sup>st</sup> State Senate District candidate and current 2<sup>nd</sup> State Assembly District Representative André Jacque (R – De Pere) announced additional endorsements today from dozens of current and former local elected officials across the 1<sup>st</sup> Senate District, including Outagamie County Republican Party Chair and County Supervisor Jim Duncan and Manitowoc County Republican Party Chair and County Supervisor Don Zimmer.
