WISCONSIN, OCTOBER — Ed Fallon, candidate for Wisconsin State Supreme Court, today announced the endorsement of elected officials and community leaders across Wisconsin.

“I am proud to endorse Ed Fallon for Wisconsin Supreme Court. I firmly believe that our highest court will thrive with Ed’s voice bringing fairness, equality, and diversity to the bench. Along with over two decades of educating our state’s judges, prosecutors, and trial attorneys, Ed has extensive knowledge of our constitution and I know he will uphold it in our court of law. Ed Fallone is a constitutional scholar who has devoted over 30 years of his life to the law and ensuring that the Wisconsin legal system works for all Wisconsinites. He has taught hundreds of judges and attorneys. Ed will be the first Latino to serve on our state's highest court and will bring a legal scholar to the Wisconsin Supreme Court. His mother was a Mexican immigrant and his father was a teacher, he comes from a working class family and has two children who attended Yale University and American University School of International Service. Ed is running for Wisconsin Supreme Court to preserve the independence of the judiciary and defend our rights to equal treatment under the law and self-governance.

The primary election for the Supreme Court will be held February 18, 2020.
