Later, moving up to the Circuit Court in Milwaukee, and serving on the bench there for 14 years. Currently, Judge Brash sits on the Court of Appeals and has been since 2015. He was named the Presiding Judge for District 1 in 2019, and has been the Chief Judge for the Court of Appeals since 2021.

District 1 of the Court of Appeals is one of four Court of Appeals districts and is located entirely in Milwaukee county.
