21. Page 1011, line 13: after that line insert:

- Ambulatory surgical center reimbursement rates under Medical ASSISTANCE PROGRAM. The department of health services shall consult with ambulatory surgical centers to develop a plan to increase reimbursement rates for ambulatory surgical centers for services provided to recipients of Medical Assistance under subchapter IV of chapter 49 of the statutes. During the 2017-19 fiscal biennium, the department of health services may submit one or more requests to the joint committee on finance to supplement the appropriation under section 20.435 (4) (b) of the statutes in a total of no more than \$2,500,000 from the appropriation under section 20.865 (4) (a) of the statutes for the purpose of increasing reimbursement rates under the Medical Assistance program for ambulatory surgical centers in accordance with the plan established under this subsection. If, within 14 days after the date of the department's submittal, the cochairpersons of the committee do not notify the department of health services that the committee has scheduled a meeting to review the request, the supplement is considered approved. If the cochairpersons notify the department of health services that the committee has scheduled a meeting to review the request, the supplement may be made only upon the approval of the committee. Notwithstanding section 13.101 (3) of the statutes, the joint committee on finance is not required to find that an emergency exists before making a supplementation under this subsection.".

- **25.** Page 1014, line 17: delete the material beginning with "1. Pure" and ending with "K0669." on page 1015, line 8.
- **26.** Page 1015, line 10: delete "listed in paragraph (b)" and substitute "designated".
 - **27.** Page 1022, line 19: after that line insert:
