Contributions to Nicholson for Senate are not tax deductible as charitable contributions for federal income tax purposes

Funds received in response to this solicitation are subject to federal contribution limits and prohibitions. Federal law limits individual contributions to \$2700 per election. For married couples, each person may contribute \$2700 per election. Multicandidate PAC's are limited to \$5000 per election, and non-multicandidate PAC's are limited to \$2700 per election. The primary and general elections are considered separate elections. Contributions from corporations, labor organizations, national banks, federal government contractors and foreign nationals who lack permanent resident status are prohibited. Federal election law requires us to use our best efforts to report the name, mailing address, occupation and name of employer of individuals whose contributions aggregate to or exceed \$200 during an election cycle.
