Dear Governor Evers and Secretary Carr,

The recent announcement from the Department of Corrections about the formation of the Critical Vacancy Rate Add-On Pilot Program, which will provide an additional \$5 per hour for only some officers based solely on the corrections facility in which they work, has raised concern in our caucus about the process used to determine who received those pay increases. All of Wisconsin's corrections officers face challenges as they work to keep their facilities secure and the public safe while also helping to rehabilitate offenders. Singling out some officers over others to receive the benefit was not well thought out. It is fundamentally unfair and creates unnecessary animosity in a system that already needs reform.

As state representatives with DOC facilities in our districts, we absolutely agree that providing raises for our correctional officers is the right thing to do. Perhaps President Ronald Reagan said it best when describing their job:

"No group of Americans has a more difficult or less publicly visible job than the brave men and women who work in our correctional facilities."

As you are aware, the recent legislative audit of the DOC determined that the vacancy rate for positions reached 14% statewide as of June 2018, which is an increase of 7.3% over 2014. That same audit showed the average starting wage for Wisconsin correctional officers is \$16.32 per hour, which is approximately \$2.00 per hour less than the average for Midwestern states.

Changes to compensation should be addressed in the upcoming state budget in order to find a sustainable solution, rather than providing temporary raises based on temporary department funds. We look forward to working with the Committee on Joint Finance to ensure all of our correctional officers are treated fairly for the incredibly difficult, but important work that they do.






