## **ERP Marks World Elder Abuse Awareness Day with Events Statewide**

Milwaukee--The Elder Rights Project (ERP) is hosting outreach presentations and participating in community discussions throughout the state leading up to World Elder Abuse Awareness Day, which lands on Saturday, June 15.

ERP, a joint collaboration of Legal Action of Wisconsin and Wisconsin Judicare, helps victims of crime who are age 60 and over with the civil legal needs that result from their victimization. The demand for services continues to climb: ERP lawyers have helped 643 clients just this year alone, with a total of 2,467 clients served since the project launched in 2016. The legal problems that result from elder abuse can be severe. In addition to finding themselves facing eviction or foreclosure as a result of the crimes committed against them, victims often need help in obtaining injunctions against their abusers, and working to recoup money, property or other assets that were stolen by abusers through exploitation or identity theft.

Every year, World Elder Abuse Awareness Day provides advocates with an important opportunity to educate the community on how to look for signs of elder abuse.

“Elder abuse victims will often start to become isolated by their abusers and will stop participating in family and social functions. They may have bruises, come across as emotionally distant, or both. They may start to fall behind on bills, and not even have a couple of dollars on them for spending money,” said ERP Project Director Nicole Zimmer. “Sometimes, just a friendly encouraging voice can be enough to convince a victim to come forward and find the legal help they need.”
