SUBJECT: Bipartisan votes

Overview

You asked us to compile and calculate the percentage of bipartisan votes cast in the Wisconsin Assembly during the 2019 legislative session. Per your request, roll call votes for which at least one member of each party cast an “aye” vote are considered bipartisan. Additionally, all voice votes are considered bipartisan. According to the information compiled, 113 of 122 bills, or 92.6 percent, had bipartisan votes. Additionally, 95 of 97 resolutions, or 97.9 percent, had bipartisan votes. In total, 208 of 219 proposals, or about 95 percent, had bipartisan votes. Complete information about these votes is included in the appendix below.
