## **What Folks are Saying: School-Based Mental Health is a Game-Changer**

**MADISON** – The Assembly Committee on Mental Health held a committee vote last week, where it unanimously approved a [School-Based Mental Health Pilot Program bill](#), authored by Representative Jim Steineke (R-Kaukauna), Senator Roger Roth (R-Appleton), and Senator Alberta Darling (R-River Hills).

The bill, which builds off the successful [Child Psychiatry Consultation Program](#), would allow school personnel to [receive assistance from trained child psychiatrists via a hotline, along with regular training opportunities](#). Following last week’s bipartisan committee vote, here’s what folks are saying about the legislation that gives schools and educators the tools they need to face the student mental health challenges school districts see every day:
