Update February 23: COVID Cases and Deaths Among People with Disabilities and Older Adults in Wisconsin

(Madison) – The Survival Coalition of more than 30 disability organizations supports the work of the Wisconsin Department of Health Services and the Governor Evers' administration to share regularly updated data regarding the impacts of COVID-19 in Wisconsin's Medicaid Adult Home and Community-Based Services system. People with disabilities and older adults, particularly those who live in congregate or group settings are particularly vulnerable to the virus. Wisconsin's long-term care program enrollment is 77,432 or approximately 1.4% of the WI population but accounts for more than 1/6 of all state COVID-19 deaths.

Survival Coalition is sharing the Department's updated data weekly.

Total cases by adult Medicaid HCBS waiver program type

Program enrollment data is point-in-time from most recent published month for each program type (currently December 1 for managed LTC and February 1 for IRIS).

Medicaid HCBS waiver program COVID-19 positive cases as percent of statewide total COVID-19 positive cases	1.7%
Medicaid HCBS waiver program COVID-19 hospitalizations as percent of statewide total COVID-19 hospitalizations	9.7%
Medicaid HCBS waiver program COVID-19 deaths as percent of statewide total COVID-19 deaths	16.8%

Participants in Wisconsin's waiver programs, typically referred to as Family Care and IRIS, comprise 16.8% of the state's total deaths.

According to DHS data, 25.8% of cases in the waiver system result in hospitalization and 11% result in death, compared to 4.6% and 1.1% in the general state population, respectively.
