SUBJECT: Federal Funding Received for School Districts Under Federal Coronavirus Aid

At your request, I am providing information about aid for K-12 school districts under the federal Elementary and Secondary School Emergency Relief (ESSER) fund and the Governor's Emergency Education Relief (GEER) fund under three federal coronavirus relief acts passed to date.

ESSER

ESSER was created under the Coronavirus Aid, Relief, and Economic Security (CARES) Act, which was enacted by the federal government on March 27, 2020. Additional funding was provided under the Consolidated Appropriations Act (CAA), which was enacted on December 27, 2020, and the American Rescue Plan Act (ARPA), which was enacted on March 11, 2021.

Under ESSER, states are required to allocate at least 90% of their received funds for direct aid to local educational agencies (LEAs), according to the formula used for the most recent distribution of Title I Part A funds under the Elementary and Secondary Education Act of 1965 (ESEA), which is based on the number of low-income pupils residing in each district. States have discretion over the use of the remaining 10% of funds, with some constraints established in the federal Acts.

Under s. 115.295 of the statutes governing federal appropriation adjustments for the Department of Public Instruction (DPI), DPI is required to submit a plan to the Joint Finance Committee if additional federal funding is received that would cause the amount of federal funds to exceed 105% of the amount of federal revenue shown in the Chapter 20 schedule for that year. The plan is then subject to a 14 day passive review. Under ESSER I and II, the DPI plan as approved by the Committee used a portion of the discretionary funds to establish a minimum grant amount for LEAs. The minimum grant amount was equal to \$40,000 under ESSER I and \$100,000 under ESSER II.

In its plan for the federal funds under ESSER III, DPI proposes using an additional \$39.4

million to establish a minimum grant amount of \$600,000 for all LEA with more than 25 pupils. (One school district and two independent charter schools with fewer than 25 pupils and the state's two residential schools for blind and deaf pupils would each receive a minimum grant \$200,000 under the plan.) The plan is subject to review by the Committee, and has not yet been approved.

In the ESSER II plan approved by the Committee, funds equal to \$65.5 million will be used to establish in-person incentive funding, with the 172 school districts and two independent charter schools that would otherwise receive less than \$395 per pupil under ESSER II eligible to compete for aid based on the number of in-person instructional hours provided to pupils in the 2020-21 school year. Allocations under this portion of the funding are not yet known.

GEER

The CARES Act also created a Governor's Emergency Education Relief (GEER) fund that was distributed to the governor of each state to allocate to K-12 local educational agencies, institutions of higher, or any other education related entity within the state. Additional funding was provided under the CAA.

On June 17, 2020, Governor Evers announced that the \$46.6 million in GEER funding under the CARES Act would be distributed to K-12 school districts, prioritizing districts based on their remote learning needs and how much they have been affected by the COVID-19 pandemic.

The distribution of GEER moneys under the CAA has not yet been announced.

Attachment

Attachment 1 shows the allocations to LEAs under ESSER I, ESSER II, ESSER III, and GEER I. For ESSER III, the attachment includes only the allocation of the 90% of funds that the federal act requires to be allocated based on the most recent distribution of Title I Part A funds under the ESEA. The attachment does not include the in-person incentive funding under ESSER II. It is not possible to estimate the allocation of funding under this provision, because the number of in-person instructional hours provided by each eligible school district and independent charter school is not known.

Attachment 2 shows the allocation of ESSER III funds under DPI's plan, including the minimum aid proposed by DPI. The plan is subject to approval by the Committee.
