## Top Slot in State Bar Elections Goes to Attorney Margaret Hickey

**Madison, WI –** Margaret W. Hickey, Hickey & Poster S.C., Milwaukee, won the race for State Bar of Wisconsin president-elect on Friday, April 23, defeating Odalo J. Ohiku, Milwaukee Office of the City Attorney.

She will be the fourth consecutive woman to serve in that role, a first in State Bar history.

Hickey's term begins July 1, 2021 when Cheryl Daniels succeeds Kathy Brost as State Bar president.

Hickey said she appreciates the confidence that State Bar members have placed in her. "I will work very hard on behalf of all members," she said. "We have learned in this past year that we can pivot when needed."

"The Bar must be as flexible and responsive as we can be to our members. We must support younger members to develop into capable, ethical attorneys; promote diversity, equity and inclusion across our membership and in the justice system; and increase access to justice in Wisconsin," Hickey said. "As president-elect I will work diligently and passionately to achieve these goals."

In other State Bar races, Elizabeth Reeths of Klinner Kramer Shull, LLP, Wausau, was elected to a two-year term as treasurer and Margo S. Kirchner of the Wisconsin Justice Institute Inc., Milwaukee, won a three-year term as Judicial Council representative.
