[Officials do not merit an August B R E A K, All Hands on Deck for the Safety of the Delta Variant](#)

MILWAUKEE, WI – We must continue to [sound the alarm](#) for responsible leadership from Governor Tony Evers (state-level), County Executive David Crowley (county-level), Mayor Tom Barrett, Kirsten Johnson, Milwaukee Health Commissioner, and the Common Council (city-level), elected and appointed members of government in Wisconsin for the city of Milwaukee – 96.8 square miles. WE EXPECT THEM TO WORK THROUGHOUT AUGUST for OUR SAFETY.

We, the People, have seen those we put our TRUST rolling the dice with complacency and failing to adopt rigorous and consistent pathways of OUTREACH that increase trustworthiness for raising the vaccination level in Milwaukee – saying one thing but doing another is one of the NO-NOs in the “Hesitancy” environments. Evers, Barrett, Crowley, and Johnson have little to NO credibility due to their obsession with the BUCKS games. They have an Oath, Mission, and salary obligation to the citizenry. It is NOT delivering the Delta Variant for a BUCKS NBA Championship. It did not have to be this way.

Dr. Ben Weston, Medical College of WI, is supposed to be the health expert. His RECITING OF .000 NATIONAL data and timid reframe of “safety in crowds” goes out the window because it has NO resonance.

There are NO regular members of the city of Milwaukee that are of COLOR in the [Tuesday and Thursday Briefings](#). Milwaukee is predominately People of Color – African Americans makeup the largest People of Color race in the largest Urban city of Wisconsin. Additionally, Crowley and Barrett have been reminded more than twice of the absenteeism of African American and People of Color media outlets for the questions and answer session. Barrett seems to think a couple of Bucks tickets (if they can get them) will move the needle pass 30% for African Americans and People of Color citizenry.

Mary Glass, Chief Visionary Officer, MPA-LLC says, "It is NOT that Evers, Crowley, Barrett, Weston, and Johnson, do not know the facts of the spread and potential spread of the highly contagious Delta Variant, they appear to be "giddy" or refuse to DO THE RIGHT THING for us. They must be chastised and allowed the NEXT TWO-THREE WEEKS to PREPARE for the epidemic they have us facing." As a matter of fact, we call for a mega partnership - a Census Tract Integrity partnership, with Peter Feigin, Bucks and Adam Silver, NBA Commissioner.

It is an American Rescue plan with urgencies and targeted funding to defeat the Delta Variant and any other viruses. It is to promote survival of the people and acquaint us all to the necessity of receiving vaccinations while understanding there are prohibitors to the vaccination due to the pandemic and epidemic we find ourselves.

For the next 2 years, it will lay the foundation for high-speed internet, top-notch healthcare, rebuilding, reframing, and TRANSFORMING the Infrastructure of Milwaukee, the city.
