As local party officials you possess tremendous clout to hold Republican elected officials accountable. You assist in vetting Wisconsin's conservative candidates, support their campaigns, and facilitate the re-election of incumbents. What happens, though, when those representatives stop acting as our *public servants* and start walking and talking as *private employees* of party leadership in Madison?

We urge you to evaluate and act accordingly.

Where were the legislators you helped elect when we all learned that Robin Vos and Scott Fitzgerald had signed off on illegal drop boxes? Did they stand up and object?
