To Republican Members of the Wisconsin State Legislature:

On March 16th, Speaker Robin Vos publicly acknowledged that he now believes widespread fraud occurred during the November 2020 election. Vos' about-face in communication came immediately after a meeting with election integrity experts and activists, during which he saw and heard enough evidence that even he could no longer reasonably deny the seriousness of the problems that pervaded that election.

At this same meeting, experts also laid out a clear path to decertification of the 2020 vote, countering Speaker Vos' continued insistence that there's nothing the Legislature can do to remedy the widespread fraud he now acknowledges took place. In fact, Article II, Section 1 of the U.S. Constitution provides for decertification by the State Legislature, as does 3 U.S.C. § 2. Moreover, the instrument to accomplish Wisconsin's decertification already exists; Assembly Joint Resolution 120, introduced on Jan 25, 2022, requires neither a governor's signature nor an attorney general's backing. The Founders provided you, as state legislators, with full authority and prerogative to correct precisely the kinds of wrongs that we all now know occurred. Instead of leveraging AJR 120, "leadership" sat on it for 45 days, then closed the spring session without touching it, hoping the entire issue of election integrity would magically disappear.

The demand of Wisconsinites for election integrity has *not* disappeared. Nor will it. November 2020 is not just water under the bridge, as you've all insisted. Decertification of an election that even Speaker Vos now concedes was rife with fraud plants a crucial first step on the path to restoring free and fair Wisconsin elections—and public trust in them. Without free and fair elections, we lose all ability to exercise the natural rights guaranteed to us by the U.S. and Wisconsin Constitutions. It's not an option to act; it's your *duty*. Yet, there you sit...flaccid.

Ask yourselves: What does Speaker Vos get out of continuing to insist, against all evidence, that the powerful Wisconsin State Legislature is impotent? What has been his motivation for keeping all of you weak in the face of a constitutional crisis?

Your impotence lies not in any defect of the Constitution you swore to uphold, but rather in your refusal to embrace it and to act. We elected you to protect our rights and voice. We fully vested you with authority to do so. Yet you stand around and pretend at powerlessness—often ignoring or demeaning us while you do so.
