She stated that it was strictly up to him whether or not he issued the citation. ESTENSON then went outside the bar and talked to Strum Police Department Chief Craig Marsolek. They engaged in some type of a conversation relating to the situation involving getting a citation for underage drinking. stated that she thought Craig Marsolek told ESTENSON not to give a citation.
DAVID ESTENSON then told that he was going to give her a ride home in the squad car. She stated she figured that whether or not she got a citation she was still going to be given a ride home. She stated that she didn't have a problem with that. She went to the squad car that ESTENSON was driving.
ESTENSON stated that she could sit up in the front of the squad car with him. She stated that she wanted to sit in the back of the squad car. ESTENSON then gave a ride home to her residence in Strum in the squad car. stated that she was not patted down prior to getting into the squad car. She stated that she was not handcuffed. She stated that while she was being transported, ESTENSON kept trying to say things to her. She stated that she got out of the squad car when ESTENSON opened the door for her. There was no other contact between her and ESTENSON.
Since October 28,2 004, has heard rumors from various individuals. Those rumors indicate that ESTENSON has approached other females that were under the legal drinking age while he was off duty and in bars. He told the girls that he would let them out of getting a citation for receiving of a "blow job". stated that she heard this information from
stated that she had heard the information from other bartenders in the Osseo, Strum and Foster, WI areas. stated that had told that had heard from other bartenders after the bartenders had talked to the girls after ESTENSON had approached the girls. had attended high school with ESTENSON. believed that approached the girls was approximately 21 years of age.
stated that she didn't believe that was still sleeping with ESTENSON. She stated, however, if investigators decided to talk with about information relating to ESTENSON, that would take the information directly back to ESTENSON.
stated that if an investigation was continued, she suggested that investigators talk to . She stated that . lives in in a house close to . She works at . and live together in

stated that she was talking about the incident between her and ESTENSON while in a bar in Whitehall. She indicated the bar was RICK & DEB's BAR. She stated at one time when she was talking about the incident TERRY MILES was present.

stated that she would try to get information about the rumors that she had heard. She stated that she would try to get names of individuals who had supposedly been approached and solicited by DAVID ESTENSON. She stated that she would re-contact S/A Sogla if she found additional information.

S/A Sogla had contacted Osseo Police Department Chief Greg Gregerson and informed him of the initial information that had been received by S/A Sogla. That contact with Chief Gregerson had occurred in approximately mid-November 2004. S/A Sogla contacted Chief Gregerson on February 4, 2005 at approximately 8:30 a.m. S/A Sogla provided the information that had been received thus far relating to DAVID ESTENSON.

Chief Gregerson indicated that he had previously heard a rumor regarding a supposed consensual activity between DAVID ESTENSON and an approximate 19-year old female. The information received indicated that at one time, approximately in the summer of 2004, DAVID ESTENSON was off duty in a bar area in Osseo. Also in the bar in Osseo was the female that was under the legal drinking age, but was present in the bar with her parents. The 19-year old female consented to going out to the alleyway area with ESTENSON. The two left the bar area in what appeared to be a consensual arrangement. The female's father walked out of the bar area and reportedly stopped any type of activity.

Chief Gregerson had confronted DAVID ESTENSON about the information. ESTENSON neither confirmed nor denied the information. Chief Gregerson had later contacted the girl on an unrelated incident. Chief Gregerson suggested that if there was anything else that she wanted to report she could do so. She did not say anything about the incident.

Chief Gregerson had also contacted the female's father. Chief Gregerson indicated that it was unrelated to any type of an investigation related to ESTENSON. The father did not mention any type of a situational problem between his daughter and ESTENSON.

Chief Gregerson indicated that he had heard information being spoken around the town of Osseo relating to DAVID ESTENSON and a girl by the first name of ". An individual had told Chief Gregerson that "was having an intimate relationship with DAVID ESTENSON. The individual told Chief Gregerson that "wanted more of a relationship with ESTENSON but ESTENSON was not interested."

On Friday, March 9, 2007, S/A Jon P. Spallees and S/A Paul H. Sogla interviewed at her residence. The interview started at approximately 11:21 a.m. and completed at approximately 11:58 a.m. She provided substantially the following information:

had first met DAVID ESTENSON while he was working as a police officer for the Strum Police Department. She stated he was also employed full time at the Osseo Police Department. While working for the Strum Police Department he would stop in and talk to her while she was working at believed that she first started having a relationship with ESTENSON in approximately the summer of 2003.

told investigators that she would describe her relationship with ESTENSON as being "friends with benefits". She stated that she had first met ESTENSON while he was going through a divorce from his first wife. She clarified that their relationship was one of a sexual nature without any so-called emotional attachments. The relationship started somewhere around the summer of 2003 about the time the Foster Days Summer Celebration had taken place.

At that time during the Foster Days in the summer of 2003, she had been talking to DAVID ESTENSON prior to going to the Foster Days. She was talking to him on the phone. She had indicated to him that she was going to be consuming intoxicating beverages. She was not of the legal drinking age at the time but was over the age of 18. ESTENSON knew that she was not of legal drinking age. She did not actually have contact with him while she was drinking intoxicating beverages. She stated she would have been approximately 19 years old at the time.

Shortly after the Foster Days Summer Celebration in the summer of 2003 she started having an intimate relationship with DAVID ESTENSON. That relationship lasted approximately one year. One time during the approximate year long intimate relationship she actually had a sexual contact with ESTENSON while he was on duty and in uniform while at the Strum Police Department building. She stated that incident would have occurred approximately a few months into the summer of 2003. She stated that there was also approximately 3-5 other times that she had a sexual relationship while he was on duty and in uniform while working for the Strum Police Department.

Shortly after commencing with the sexual relationship with ESTENSON, he had made a comment to her that she took as somewhat of a threat. He had told her that if she told anyone about his having a sexual relationship with her, she would have problems. He made the comment that if she told anyone about their sexual relationship, things would be found in her car that she could be arrested for and/or cause problems for her. He stated that things would be planted in her car to cause the arrest. She stated because of the comments made to her, she started and continues to this time, to keep the doors on her car locked.

stated that there were various times that ESTENSON requested that she have anal sex with him. She stated that she didn't desire to have that type of a sexual relationship. At one point when they were approximately 6 months into the relationship, she had traveled to ESTENSON's house in Osseo. He had continued to ask her to have anal sex with him. She stated that she did not want to. She stated that ESTENSON was persistent and that she eventually gave in. That was the only time that there was that type of a sexual contact.

stated that there were several times that she traveled to ESTENSON's house in Osseo. She thought she had traveled to his house approximately 2-3 times. During those times she did have a sexual relationship with ESTENSON. There was also a time where she had traveled to his house in Osseo when she was under the age of 21 in which ESTENSON had asked her if she wanted to drink a beer while in his house. ESTENSON knew that she was under the legal drinking age. She had declined taking the beer.




ESTENSON has an Associate Degree from Chippewa Valley Technical College in Eau Claire, WI. ESTENSON graduated from CVTC in 2002. ESTENSON worked as a part time police officer in the Village of Strum, WI from 2001, to 2004. ESTENSON received his law enforcement certification from the State of Wisconsin in September, 2001. On October 1, 2002, ESTENSON became employed full time as a police officer with the City of Osseo, WI.

S/A Sogla asked ESTENSON if ESTENSON knew why the agents wanted to interview him. ESTENSON stated that he suspected that the interview was being conducted as a result of an allegation of solicitation for sexual favor by . ESTENSON stated that he had been told of these allegations in the past by "GUMBY", a/k/a Chief Greg Gregerson of the Osseo Police Department. ESTENSON stated he had an "eyewitness" (concealed camera recording device) on his person on an evening when ESTENSON had come out of a bar in Strum while ESTENSON was on duty. ESTENSON did not have the recording device activated/on during that contact.

ESTENSON stated he was not involved in a relationship with . ESTENSON had been involved with a friend of who he could not immediately identify by name. Subsequently during the course of the interview ESTENSON recalled that the name of this female was .

ESTENSON stated he had a "physical kind of thing for about 8 months" with ESTENSON stated that he was involved with "quite a few" women in the past.

ESTENSON stated he was married in June, 2001. ESTENSON was divorced in the summer (June) of 2004. ESTENSON stated he was single at the time of his relationship with and he was not seriously dating anyone. ESTENSON was separated from his former wife in November, 2003.
ESTENSON stated he had been involved in several relationships with females while employed as a police officer with the City of Osseo. ESTENSON first dated , and . ESTENSON stated he had "a whole bunch of one night stands".
ESTENSON also dated in 2005. was reported to be 20 years old at that time. ESTENSON dated for a couple of months.
On one occasion while dating Eau Claire, WI with ESTENSON stated the "she drank twice", indicating that under age in ESTENSON's presence on two occasions. ESTENSON purchased a "fruity" alcoholic beverage for while at the Court 'N House Bar. ESTENSON stated that had "some girly drink," as he could not recall specifically what the beverage was. ESTENSON recalled that this incident at the Court 'N House Bar occurred in October, 2005.
ESTENSON was with Wisconsin State Patrol Trooper DAN GRUEBLE and Sgt. MIKE NEWTON of the Wisconsin State Patrol at the Court 'N House Bar. They also met with . ESTENSON stated that NEWTON purchased an alcoholic beverage for while at the Court 'N House Tavern. ESTENSON stated he did not believe that Trooper GRUEBLE or Sgt. NEWTON knew that time.
ESTENSON and went to residence near Claire, WI by .
ESTENSON stated that he met through .
ESTENSON also drank an alcoholic beverage with in Osseo in September, 2005 at JOHN ELKINS' residence. ESTENSON and in Osseo that evening. ELKINS had beer at the residence. ESTENSON stated he didn't know that date. ESTENSON stated he didn't realize was under the legal drinking age until he "hooked up" with her.
ESTENSON met in Strum, WI. was a friend of ESTENSON was working as a part time police officer for the Village of Strum at that time ESTENSON described as having



ESTENSON always had sexual encounters at his residence in Osseo with
. The encounters never occurred in Strum, WI. was
living in , WI at that time.
ESTENSON is currently involved in a relationship with CHRISTINE DANIELS.
ESTENSON agreed to take a polygraph, stating "I would love to take one".
ESTENSON stated he is currently on the eligibility, or hiring list for Minnetonka, MN
Police Department. ESTENSON has also been applying to other police departments in
the State of Minnesota, including New Hope Police Department, Brooklyn Park Police
Department, Savage Police Department and Wright County Sheriff's Department.
ESTENSON again denied any non-consensual sexual relationships with any females.
ESTENSON again denied ever being involved with a female while on duty as a police
officer.
S/A Sogla asked ESTENSON about a possible statement that ESTENSON had made to a
female (b/t/b), in which ESTENSON stated that something might be
planted in the female's car. ESTENSON denied ever making a threat or statement about
planting items in anyone's car. ESTENSON stated that he may have said, "If you are
with me you don't have to worry about getting a ticket."
ESTENSON stated he did receive a Policy Manual from the Osseo Police Department
upon his hiring. ESTENSON has read "bits and pieces" of the manual. ESTENSON did
not read a manual from the Strum Police Department.
He invited to come over to his residence to watch a movie.
ESTENSON related another incident with a female in Osseo, WI. ESTENSON explained
that in the summer of 2004, he met a girl known only as "or possibly "LNU (b/t/b") while at the SWING INN TAVERN
in Osseo, WI. "LNU was underage at that time. She was in the
tavern with her parents. She was consuming alcohol with her parents while in the tavern.
ESTENSON was in the tavern and off-duty. ESTENSON had been drinking alcoholic
beverages. ESTENSON denied providing any alcoholic beverages to "LNU. ESTENSON went behind the SWING INN TAVERN on that
Erro. Esterison went behind the Switte Hitt Trivered on that
