The Wisconsin Economic Development Corporation (WEDC) has completed the Electronics and Information Technology Manufacturing Zone Tax Credit verification of jobs/capital investment for the period ending December 31, 2021 for FEWI Development Corporation and the following related entities; AFE, Inc., FII USA, Inc. and, SIO International Wisconsin, Inc, regarding project number 23932.

Enclosed please find the verification forms, which indicate the eligible credits for the recipients. This form must be attached to the Wisconsin Income Tax Return. A certified firm can file for Electronics and Information Technology Manufacturing Zone Tax Credits using the Wisconsin Schedule EIT tax form. A total of \$7,597 in Capital Investment Tax Credits which were earned in 2021 was withheld from the attached 2021 verification to cover an over-verification of the same amount from 2020, resulting from the submission of revised capital investment information for reporting year 2020.

Although WEDC has verified eligible expenses on the attached form, the Department of Revenue may also review claims for Electronics and Information Technology Manufacturing Zone Tax Credits and make adjustments in credit amounts if necessary, to ensure compliance with the credit rules.
