Contributions from corporations, foreign nationals (without "green cards"), federal government contractors, and national banks are prohibited. The maximum that an individual may contribute is \$6,600 (\$3,300/primary & \$3,300/general). The maximum that a couple using a joint account may contribute is \$13,200 (\$6,600/primary & \$6,600/general). A federal multi-candidate PAC may contribute \$10,000 (\$5,000/primary & \$5,000/general).
