

Senate Bill 291 (Campaigns and Elections) (AB 300, A-Campaigns and Elections)  
Relating to: an election official's personal information, battery against election officials, whistleblower protection for municipal clerks, county clerks, and election officials who witness and report election fraud or irregularities, and providing a penalty.

Senate Bill 11 (Received) (AB 17, A-Judiciary)  
Relating to: expanding the treatment alternatives and diversion programs.

Senate Bill 58 (Received) (AB 64, A-Agriculture)  
Relating to: nitrate contamination and the well compensation grant program.

Senate Bill 72 (Received) (AB 78, A-Criminal Justice and Public Safety)  
Relating to: increased penalties for crimes against adults at risk; restraining orders for adults at risk; freezing assets of a defendant charged with financial exploitation of an adult at risk; sexual assault of an adult at risk; and providing a penalty.

Senate Bill 117 (Received) (AB 145, A-Government Accountability and Oversight)  
Relating to: obtaining attorney fees and costs under the state's public records law when an authority voluntarily or unilaterally releases a contested record after an action has been filed in court.

Senate Bill 127 (Received) (AB 125, A-Health, Aging and Long-Term Care)  
Relating to: requiring informed consent before performing a pelvic examination on a patient who is under general anesthesia or unconscious.

Senate Bill 135 (Received) (AB 135, A-Regulatory Licensing Reform)  
Relating to: reciprocal credentials.

Senate Bill 155 (Received) (AB 162, A-Health, Aging and Long-Term Care)  
Relating to: notification of certain facility closures, change in type or level of services or means of reimbursement accepted, and care management organization notification of contract termination with a provider that is a nursing home or community-based residential facility.

Senate Bill 241 (Received) (AB 234, A-Rules)  
Relating to: a school psychologist loan program, and making an appropriation.

Senate Bill 257 (Received) (AB 257, A-Health, Aging and Long-Term Care)  
Relating to: patients' and residents' rights to visitors in a health care facility, restricting visitation, and liability for the actions of visitors.

Senate Bill 275 (Received) (AB 280, A-State Affairs)  
Relating to: statutory recognition of specialized treatment court and commercial court dockets.

Senate Bill 331 (Received) (AB 334, A-Criminal Justice and Public Safety)

Relating to: pen registers and trap and trace devices.

Senate Bill 343 (Received) (AB 357, A-Criminal Justice and Public Safety)

Relating to: the definition of abortion.

Senate Bill 344 (Received) (AB 343, A-Ways and Means)

Relating to: designating an unborn child as a dependent for income tax purposes and increasing the income tax exemption for a dependent.

Senate Bill 345 (Received) (AB 344, A-State Affairs)

Relating to: grants to Choose Life Wisconsin and making an appropriation.

Senate Bill 395 (Received) (AB 403, A-Education)

Relating to: restrictions on the revenue ceiling for school districts.

Senate Bill 404 (Received) (AB 421, A-State Affairs)

Relating to: penalties for operating a motor vehicle without a license or after license suspension or revocation and providing a penalty.

Senate Bill 477 (Received) (AB 504, A-Rules)

Relating to: attendance of children at public events with groups of nude adults and providing a penalty.

Senate Bill 559 (Received) (AB 477, A-State Affairs)

Relating to: delivery network couriers and transportation network drivers, Department of Financial Institutions' approval to offer portable benefit accounts, providing for insurance coverage, modifying administrative rules related to accident and sickness insurance, and granting rule-making authority.

Senate Bill 612 (Received) (AB 649, A-Transportation)

Relating to: seasonally maintained highways.

Senate Bill 653 (Received) (AB 680, A-Education)

Relating to: state aid adjustments under the full-time open enrollment program.

Senate Bill 740 (Received) (AB 767, A-Transportation)

Relating to: personalized registration plate fees for gold star family special registration plates.

Senate Bill 767 (Received) (AB 817, A-Campaigns and Elections)

Relating to: the provision of absentee ballots to nonresident students at the University of Wisconsin System.

Senate Bill 809 (Received) (AB 926, A-Criminal Justice and Public Safety)

Relating to: entering certain places with intent to commit battery and providing a penalty.

Senate Bill 906 (Received) (AB 987, A-Environment)

Relating to: education about rechargeable batteries and providing grants for collecting and recycling rechargeable batteries.

Senate Bill 944 (Received) (AB 1032, A-Criminal Justice and Public Safety)

Relating to: the availability of information on crimes through the consolidated court automation programs.

Senate Bill 962 (Received) (AB 1057, A-Health, Aging and Long-Term Care)

Relating to: the procedure for adding federal newborn screening recommendations to the state-required newborn screenings, granting rule-making authority, and providing an exemption from emergency rule procedures.

Senate Bill 1006 (Received) (AB 1038, A-Sporting Heritage)

Relating to: the wildlife damage abatement program and the wildlife damage claim program.

Senate Bill 24 (Rules) (AB 25, A-Agriculture)

Relating to: the distribution and labeling of fertilizers and soil or plant additives produced from manure.

Senate Bill 54 (Rules) (AB 113, A-State Affairs)

Relating to: the amount of allowable cash withdrawal from a bingo account for the purpose of paying cash prizes.

Senate Bill 83 (Rules) (AB 82, A-Local Government)

Relating to: including with a referendum question for issuing bonds a statement of the estimated interest accruing on the amount of the bonds.

Senate Bill 93 (Rules) (AB 106, A-Workforce Development and Economic Opportunities)

Relating to: grants to technical college and tribal college students for apprenticeship expenses and making an appropriation.

Senate Bill 97 (Rules) (AB 89, A-Rules)

Relating to: penalties for certain traffic violations where highway maintenance workers are present and providing a penalty.

Senate Bill 110 (Rules) (AB 114, A-Health, Aging and Long-Term Care)

Relating to: extension of eligibility under the Medical Assistance program for postpartum women.

Senate Bill 122 (Rules) (AB 121, A-Rules)

Relating to: requiring the Department of Financial Institutions to implement a section 529A ABLE savings account program and granting rule-making authority.

Senate Bill 177 (Rules) (AB 188, A-Rules)

Relating to: fatality review teams and granting rule-making authority. Joint Legislative Council.

Senate Bill 224 (Rules) (AB 227, A-State Affairs)

Relating to: sick leave for state legislators.

Senate Bill 238 (Rules) (AB 239, A-Rules)

Relating to: tuition and fee remission for eligible veterans' spouses and children enrolled in the University of Wisconsin System or a technical college.

Senate Bill 269 (Rules) (AB 331, A-Rules)

Relating to: grants to map, control, eradicate, monitor, and minimize the spread of wild parsnip; funding for the Bureau of Natural Heritage Conservation; granting rule-making authority; and making an appropriation.

Senate Bill 274 (Rules) (AB 277, A-Housing and Real Estate)

Relating to: the amount and distribution of the real estate transfer fee.

Senate Bill 278 (Rules) (AB 283, A-Rules)

Relating to: aids to counties and municipalities for certain special election costs and making an appropriation.

Senate Bill 346 (Rules) (AB 336, A-Rules)

Relating to: a grant program for financial assistance for adoption and making an appropriation.

Senate Bill 391 (Rules) (AB 382, A-Regulatory Licensing Reform)

Relating to: ratification of the Social Work Licensure Compact.

Senate Bill 407 (Rules) (AB 418, A-Health, Aging and Long-Term Care)

Relating to: healthy aging grants and making an appropriation.

Senate Bill 478 (Rules) (AB 503, A-Rules)

Relating to: intentional exposure of genitals and providing a penalty.

Senate Bill 553 (Rules) (AB 608, A-Criminal Justice and Public Safety)

Relating to: representations depicting nudity and providing a penalty.
