

AB 14: repair and replacement of implements of husbandry under warranty.

AB 851: license requirement exemption for retail food establishments that sell or process cotton candy.

AB 38: absentee ballot request and return confirmation.

AB 39: changes to the low-income housing tax credit.

AB 51: appointment of certain lawfully present aliens as law enforcement officers.

AB 95: eligibility for local office following removal.

AB 102: reducing the eligibility threshold to claim the veterans and surviving spouses property tax credit.

AB 155: the sale or rental of soda water beverage equipment and coin-operated vending machines.

AB 176: permitting pharmacists to prescribe certain contraceptives, extending the time limit for emergency rule procedures, providing an exemption from emergency rule procedures, granting rule-making authority, and providing a penalty.

AB 181: earned release for inmates upon the completion of an employment readiness training program and granting rule-making authority.

AB 211: authorization for tribal governments to copy certified copies of vital records for administrative use.

AB 255: creating a rural pharmacy practice grant program administered by the Higher Educational Aids Board, exempting from taxation amounts received from such a grant program, and granting rule-making authority.

AB 291: waiting period for marriage after divorce judgment.

AB 419: creating an online, interactive carbon calculator for farmers.

AB 466: consumer data protection and providing a penalty.

AB 493: counting write-in votes in the general election.

AB 511: permits for certain oversize or overweight vehicles transporting forest products.

AB 549: grants related to technical college manufacturing and truck driving programs and making an appropriation.

AB 577: an election official's personal information; battery against election officials; whistleblower protection for municipal clerks, county clerks, and election officials who witness and report election fraud or irregularities; harassing election officials; and providing a penalty.

AB 615: creating a task force on missing and murdered African American women and girls.

AB 625: office requirements for motor vehicle wholesaler licensees.

AB 953: agreements for direct primary care.

AB 968: appropriating money for grants to schools to acquire proactive threat detection equipment and software and making an appropriation.

AB 979: a human trafficking victim services grant program, granting rule-making authority, and making an appropriation.

AB 981: instruction on human trafficking in licensed schools of barbering, schools of cosmetology, and specialty schools.

AB 1088: consent to admissions to certain health care facilities by patient representatives, allocation of nursing beds for patients with certain complex needs, and a complex patient pilot program.

AB 148: disenrollment of ineligible individuals from and redeterminations of eligibility for the BadgerCare Plus program and database confirmation for public assistance program eligibility.

AB 779: apprenticeship and youth apprenticeship completion awards, career and technical education incentive grants and completion awards, technical preparation programs in school districts and technical colleges, creating an individual income tax credit for completing an apprenticeship program, rejection criteria for part-time open enrollment applications, extending the time limit for emergency rule procedures, and providing an exemption from emergency rule procedures.

AB 53: reporting certain crimes and other incidents that occur on school property or school transportation and granting rule-making authority.

AB 210: pupils wearing traditional tribal regalia at a graduation ceremony or school-sponsored event.

AB 214: a lifetime license that authorizes an individual to teach an American Indian language in an American Indian language program and modifying rules promulgated by the Department of Public Instruction.

AB 542: grants to schools to acquire proactive firearm detection software and making an appropriation.

AB 575: the mental health training program provided by the Department of Public Instruction.

AB 638: requiring school boards to make textbooks, curricula, and instructional materials available for inspection by school district residents.

AB 644: applications for full-time open enrollment.

AB 898: required instruction in civics in the elementary and high school grades, high school graduation requirements, and private school educational program criteria.

AB 900: reductions to state aid paid to school districts for payments made under parental choice programs and the Special Needs Scholarship Program.

AB 937: incorporating cursive writing into the state model English language arts standards and requiring cursive writing in elementary grades.

AB 977: required human trafficking prevention instruction in certain grades and teacher training related to identifying victims of child trafficking.

AB 1016: requiring public and private schools to offer a minimum amount of physical activity each week.

AB 1024: notice to the parent or guardian of a habitually truant child.

AB 1026: prohibiting grade promotion on the basis of absences from school.

AB 1029: including truancy information in the school district and school accountability report.

AB 1034: participation in interscholastic athletics and application of the public records and open meetings laws to interscholastic athletic associations.

AB 19: spinal cord injury research grants and symposia and making an appropriation.

AB 270: hunter education requirements for persons under the age of 18 and granting rule-making authority.

AB 578: financial exploitation of vulnerable adults.

AB 1036: changes to certain nonresident hunting, trapping, and fishing approval fees.

AB 42: selection of architects and engineers for state projects.

AB 96: developer-financed tax incremental districts.

AB 622: multijurisdictional business improvement districts, annual reports for neighborhood improvement districts, and certain notifications for neighborhood improvement districts and business improvement districts.

AB 671: protective occupation annuitants in the Wisconsin Retirement System who are rehired by a participating employer.

AB 736: establishing a Palliative Care Council.

AB 1068: use of artificial intelligence by state agencies and staff reduction goals.

AB 1014: childhood obesity prevention and management grants.

AB 1015: childhood obesity prevention and management grants and making an appropriation.

AB 1086: funding for supplemental payments to hospitals with avoidable patient days under the Medical Assistance program, for enhanced nursing home reimbursement rates under the Medical Assistance program for residents with bariatric and extensive wound care needs, and for the complex patient pilot program.

AB 1087: supplemental payments to hospitals with avoidable patient days and an enhanced rate to nursing homes for bariatric and extensive wound care under the Medical Assistance program.

AB 182: a certification of rental readiness and funding to cover damages caused by certification of rental readiness holders.

AB 689: pay for performance grant requirements, use of public lands to provide temporary residence for the homeless, and providing a penalty.

AB 37: expungement of records of certain crimes and discrimination based on expunged conviction.

AB 58: mandatory minimum sentence for felons who illegally possess a firearm and providing a penalty.

AB 70: participation in a riot and providing a penalty.

AB 129: sexual assault by a health care provider and providing a penalty.

AB 460: index of discovery for district attorneys and public defenders.

AB 560: the use of videoconferencing technology in certain civil actions.

AB 970: sex offender registration for certain crimes.

AB 972: solicitation for prostitution and providing a penalty.

AB 124: the definition of public zoos and aquariums for purposes of captive wildlife regulations.

AB 337: eliminating the 13-week limit on the garnishment of earnings of certain debtors.

AB 798: petroleum products, storage of dangerous substances, and granting rule-making authority.

AB 90: third-party processing of applications for occupational therapists and occupational therapy assistants and granting rulemaking authority.

AB 143: prohibiting statutes and rules examinations for certain professions.

AB 202: investigations of conviction records by the Department of Safety and Professional Services for purposes of determining eligibility for credentials and granting rule-making authority.

AB 204: renewal dates and continuing education requirements for certain credentials issued by the Department of Safety and Professional Services and credentialing boards and granting rule-making authority.

AB 205: practice of certain professions by credential holders from other states.

AB 206: requiring the Department of Safety and Professional Services to post certain credential information on its website.

AB 332: reciprocal credentials.

AB 959: the Occupational Therapy Examining Board.

AB 975: abortion if the probable postfertilization age of an unborn child is 14 or more weeks and requiring a referendum.

AB 378: designating University of Wisconsin and technical college sports and athletic teams based on the sex of the participants.

AB 387: creating a child care reimbursement account program, providing an income tax subtraction for certain contributions to a child care reimbursement account, and granting rule-making authority.

AB 389: the regulation of large family child care centers.

AB 390: modifying administrative rules relating to assistant child care teachers.

AB 391: modifying administrative rules regarding the number of child care workers and children in group child care centers.

AB 392: allowing certified child care operators to provide care to up to six children.

AB 730: the distribution of certain materials to minors.

AB 470: an incumbent transmission facility owner's right to construct, own, and maintain certain transmission facilities and Public Service Commission procedures if the transmission facility is a regionally cost-shared transmission line.

AB 69: reporting to law enforcement certain crimes and other incidents that occur in or on public school buildings and grounds, requiring certain schools to employ armed school resource officers, and allocating federal American Rescue Plan Act of 2021 funding to reimburse schools for costs of employing armed school resource officers.

AB 320: permits for constructing or enlarging artificial water bodies for the purpose of nonmetallic mining reclamation and modifying administrative rules promulgated by the Department of Natural Resources.

AB 571: maintenance of the voter registration list, training of municipal clerks, data sharing agreements, pre-election procedures, lines at the polls on election day, and granting rule-making authority.

AB 974: the civil causes of action for human trafficking and trafficking a child.

AB 1025: definitions related to truancy.

AB 1027: funding a truancy reduction grant program and making an appropriation.

AB 1028: a truancy reduction grant program.

AB 552: setting a maximum age for serving as a supreme court justice or judge of a court of record.

AB 567: transmitting and canvassing absentee ballots, use of central counting locations, election night reporting, whistleblower protection for municipal clerks, notifications and verifications concerning citizenship status, court determinations of incompetency and ineligibility to vote, and providing a penalty.

AB 91: exempting veterans and members of the armed forces from admissions application fees at University of Wisconsin System schools and technical colleges.

AB 302: a sales and use tax exemption for data center equipment or software.

AB 304: creating the Division of Alcohol Beverages attached to the Department of Revenue; the regulation of alcohol beverages and enforcement of alcohol beverage laws; interest restrictions relating to, and authorized activities of, brewers, brewpubs, wineries, manufacturers, rectifiers, wholesalers, and retailers; shipping alcohol beverages by means of fulfillment houses and common carriers; the consumption of alcohol beverages in a public place; creating a no-sale event venue permit; creating an operator's permit; liquor licenses transferred from one municipality to another; retailers' authorized activities; liquor license quotas; the safe ride program; the presence of underage persons and conduct of other business on licensed premises; the occupational tax on alcohol beverages; repealing a rule promulgated by the Department of Revenue; granting rule-making authority; and providing a penalty.

AB 551: freedom of speech and of the press in school-sponsored media.

AB 553: free speech and academic freedom at University of Wisconsin System institutions and technical colleges, due process in disciplinary proceedings at University of Wisconsin System institutions and technical colleges, Wisconsin grant funding allocation, and causes of action against the Board of Regents of the University of Wisconsin System and technical college district boards.

AB 554: race-based higher education programs and requirements.

AB 891: academic and career planning services provided to pupils, requiring the reporting of certain data on college student costs and outcomes, and granting rule-making authority.

AJR 66: requiring a supermajority in each house of the legislature for passage of tax increase legislation (first consideration).
