Nationwide Conservatives Support Recall of Robin Vos Amid Accusations of Misinformation and Compromise

Union Grove, WI – May 6, 2024 – In an unprecedented move, notable constitutional conservatives from across the nation, including former President Donald Trump's National Security Adviser General Michael Flynn (USA Ret.), MyPillow CEO Mike Lindell, and former Wisconsin Supreme Court Justice Michael Gableman have joined forces with local leaders to call for the recall of Wisconsin Assembly Speaker Robin Vos.

Recent activities have surfaced showing Speaker Vos and his supporters actively discouraging constituents from signing a new petition, spreading misleading information about the recall effort. Contrary to claims by Vos that the recall is a partisan liberal initiative, a recently released letter shows broad support from conservative figures and groups throughout Wisconsin and the nation. This includes endorsements from several county Republican committee chairs.

Misrepresentations by Speaker Vos extend to financial concerns, with Vos citing an inflated \$450,000 cost for the recall election, whereas fiscal estimates indicate that only \$30,000 from already allocated election funds would be needed. This comes in the wake of Vos approving a controversial \$400 million grant to the Milwaukee Brewers.

Further controversy surrounds Speaker Vos after allegations by Wisconsin Assembly Member Janel Brandtjen regarding his potential compromises with the Chinese Communist Party (CCP). Brandtjen highlighted troubling

incidents where Vos appeared to obstruct legislative reforms aimed at preventing CCP acquisitions of Wisconsin farmland, raising serious concerns about his allegiances.

The Racine Recall Committee urgently requests residents of Racine County in District 63 to support the recall effort by signing the petition. The community and supporters are urged to unite in this effort to address the misleading actions and compromised positions of Speaker Vos.
