## **Re: Recall Petition Against Representative Robin Vos**

Dear Representative Vos and Mr. Snorek:

The Commission will consider the recall petition filed by Matt Snorek and Racine Recall against Representative Vos, and the associated challenge filings, during its June 27, 2024, in-person meeting. The meeting is scheduled to begin at 10:00 a.m. A representative for the petition may provide a 5-minute presentation and a representative for the challenge may provide a 5-minute presentation. These presentations should be limited to the validity of the recall petition and the challenges to the petition. The statements will not be made under oath, and this will not be an opportunity to add to the factual record.

Additionally, if the Commission finds the petition sufficient and accepts it for filing, the Commission Chair has indicated that she will offer each representative the opportunity to present to the Commission again for 5 minutes on the question of where and when a recall election should take place. In support of this presentation, each representative may submit in writing a letter brief on where and when the election should take place should the Commission find the recall petition sufficient. This optional letter brief should be no more than 3 pages and must be emailed to brandon.hunzicker@wisconsin.gov, with all emails listed above copied, by 4:30 p.m. on Wednesday, June 26. It is recommended that any such analysis address the Supreme Court's holding in *Clarke*.

**The Commission meeting will be held in person in Room 412 East of the Wisconsin State Capitol building, which is located at 2 East Main Street, Madison, WI 53702.** There will be a Zoom link available if it is not possible for a representative to appear in person. It is strongly recommended that if presenting by Zoom, the representative appear on camera. If a representative needs to appear by Zoom instead of in person, please notify me no later than 4:30 p.m. on Wednesday, June 26.
