Dear Mr. LoCoco:

This letter is in response to your public records request dated March 17, 2023, which requested "[a]ll correspondence from March 17, 2022 to March 17[,] 2023 between:"

- 1. "Douglas La Follette and Governor Tony Evers";
- 2. "Douglas La Follette and Sarah Godlewski"; and
- 3. "Douglas La Follette and any Wisconsin Deputy Secretary of State."

A "record" is "created or is being kept by an authority." Wis. Stat. § 19.32(2). An "authority" includes a state office "having custody of a record." Wis. Stat. § 19.32(1).

After conducting a search for records to your request, the Office of the Secretary of State did not locate any responsive records and thus does not have custody of any responsive records. This Office's previous email to you stating that it was "gathering" records was not intended to imply that records had been found; it was merely intended to inform you that the Office was searching for records. When an authority has no responsive records, a response is not required. *See J. Times v. Police & Fire Comm'rs Bd.*, 2015 WI 56, ¶ 55, 362 Wis. 2d 577, 866 N.W.2d 563 (quoting Wis. Dep't of Justice, Wisconsin Public Records Law, Compliance Outline (Sept. 2012)). Therefore, this letter is being provided to you only as a courtesy.

Notwithstanding that this Office does not have custody of any responsive records, in the spirit of openness and transparency, Sarah Godlewski, the current Secretary of State, in her personal capacity, has decided to disclose her own personal emails that, if she were subject to your public records request, would be responsive to paragraph b.

Enclosed are email communications between Douglas La Follette on his sosdoug@hotmail.com address and Sarah Godlewski on her home email address, which is not being revealed. (Emails are dated Nov. 6, 2022, Jan. 24, 27, 29, and 30, 2023, and March 7, 8, and 13, 2023.) Please be aware that Sarah Godlewski was a private citizen at the time of all but one of the emails. As for that November 6, 2022, email that she received in her capacity as a private citizen, Sarah Godlewski occupied the Office of State Treasurer. (Her term ended on January 3, 2023.) Also, please be aware that Sarah Godlewski was sworn in as Secretary of State on March 18, 2023. Accordingly, the enclosed copies of email communications are not "records" and are being provided in response to your public records request only as a courtesy.
