Omnibus Motion

Motion:

Move to incorporate the following items into the substitute amendment.

1. *Wisconsin Healthcare Stability Plan (Paper #445)*. Increase the maximum amount of reinsurance payments under the Wisconsin healthcare stability plan from \$230,000,000 to \$265,000,000, beginning in plan year 2026.
2. *Wisconsin Healthcare Stability Plan--2025 Plan Year Payments*. Direct OCI to pay all reinsurance claims for plan year 2025, up to a maximum of \$265,000,000, notwithstanding the current law limit of \$230,000,000. Increase estimated GPR funding for making 2025 plan year payments by \$35,000,000 in 2026-27, bringing the total to \$41,712,800 GPR, to reflect an increase in the GPR sum sufficient appropriation for making reinsurance payments.
3. *Insurance Fraud Paralegal Position (Page 348, #6)*. Provide \$61,300 PR in 2025-26 and \$81,700 PR in 2026-27, and 1.0 PR paralegal-advanced position to assist with OCI's insurance fraud investigation activities.
4. *Board on Aging and Long-Term Care's Medigap Helpline (Page 348, #7)*. Provide \$50,300 PR in 2025-26 and \$61,000 PR in 2026-27 to increase the amount of insurance fee revenue used to support telephone counseling services provided by the Board on Aging and Long-Term Care.
5. *Information Technology (Page 349, #8)*. Provide \$309,000 PR annually to fund projected increases in OCI's information technology costs, including for contracted staffing, equipment replacement and maintenance, and software.
6. *Electronic Security Protection (Page 349, #9)*. Provide \$50,000 PR annually to upgrade and maintain electronic security systems used to safeguard confidential documents generated and used in the course of financial and market regulation examinations conducted by OCI.
7. *HIRSP Account Balance Transfer (Page 349, #11)*. Specify that any balance of moneys that was credited to the appropriations for the wind-down plan and the operational expenses of the Health Insurance Risk-Sharing Plan (HIRSP), and that was not lapsed as a result of 2015 Act 55 is transferred in 2025-26 to OCI's general program operations appropriation. Increase estimated PR revenue by \$471,700 in 2025-26 to reflect this transfer.
8. *GPR-Earned Reestimate*. Increase estimated GPR-earned revenue by \$1,100 in 2025-26

and reduce estimated GPR-earned revenue by \$501,700 in 2026-27 to reflect changes to the annual lapse of PR account balances to the general fund as a result of changes to base funding and revenues under this motion.

[Change to Base: \$470,600 PR, \$1,100 GPR-Earned, \$471,700 PR-REV, and 1.0 PR position in 2025-26 and \$35,000,000 GPR, \$501,700 PR, -\$501,700 GPR-Earned, and 1.0 PR position in 2026-27]
